ORDINANCE NO. 75-124

AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA,  
AMENDING THE URBAN RENEWAL PLAN FOR MARIPOSA  
MEDICAL CENTER PROJECT.

WHEREAS, on January 14, 1969, the Council enacted Ordinance No. 69-11 approving the Urban Renewal Plan and the Feasibility of Relocation for the Mariposa Medical Center Project; and

WHEREAS, on April 20, 1970, the Council enacted Ordinance No. 72-26 approving an amendment of the Urban Renewal Plan for the Mariposa Medical Center Project; and,

WHEREAS, further amendments of the Urban Renewal Plan for the Mariposa Medical Center Project have been proposed and are shown in Exhibit "A" attached hereto and called Proposed Amendments To Urban Renewal Plan Mariposa Project, dated September 24, 1975; and,

WHEREAS, the Planning Commission adopted Resolution No. 5864 recommending to the Council the adoption of such further amendments as shown in such Exhibit "A"; and,

WHEREAS, on November 20, 1975, the Redevelopment Agency of the City of Fresno and the Council held a duly noticed, joint public hearing to consider such further amendments and all evidence and testimony relating to such further amendments; and,

WHEREAS, the Redevelopment Agency of the City of Fresno adopted Resolution No. 973 at the conclusion of such joint public hearing approving for itself and recommending to the Council the adoption of the Proposed Amendments To Urban Renewal Plan Mariposa Project, dated September 24, 1975.

NOW, THEREFORE, the Council of the City of Fresno does  
ordain as follows:

SECTION 1. The Urban Renewal Plan for Mariposa Medical  
Center Project, as adopted pursuant to Ordinance No. 69-11  
and an amended ordinance, Ordinance No. 72-26, as amended  
in the particular set forth in the Proposed Amendments To  
Urban Renewal Plan Mariposa Project, dated September 24, 1975,  
attached hereto as Exhibit "A" and made a part of this ordinance  
with the same force and effect as if fully set forth herein,  
as follows:

Text shown in italicized type is added.

Article IX - Official Actions To Effect The Plan  
is deleted and Article IX - Official Actions To Effect  
The Plan, commencing on page 23, is added.

Exhibits 1, 2, and 3 are amended to read and  
depict in their entirety as shown on Exhibits 1, 2,  
and 3 to Exhibit "A."

SECTION 2. This ordinance shall become effective and  
in full force and effect at 12:01 A.M. on the thirty-first day  
after its passage.
